THIS INDENTURE, Made this twenty-second day of April A. D. 1902,
BETWEEN Edith Jenkins of the County of Lander State of Nevada the party of
the first part, and the W. T. Jenkins Company a corporation organized under
the laws of the State of Nevada and having its principal place of business at Battle
Mountain in said County of Lander , the party of the second part,

WITNESSETH: That the said party of the first part, for and in consideration of the
sum of fifteen DOLLARS, lawful money of the United States of America, to
her in hand paid by the said party of the second part, the receipt whereof is
hereby acknowledged, has granted, bargained and sold, conveyed and confirmed, and
by these presents does grant, bargain and sell, convey and confirm, unto the said
party of the second part, and to its successors ~~heirs~~ and assigns forever, all
those certain lots, pieces or parcels of land situate, lying and being in the
County of Humboldt , State of Nevada , and bounded and particularly de-
scribed as follows, to wit:

All of those certain premises situate on or near Casey Creek in the Tobin Range of
mountains south of the Neffman Ranch known as the Buffalo Ranch. Said premises
contain about 160 acres of land and were and are the same premises which were sold
by W. J. Stephens and Louise Stephens to Wess R. Jenkins in July 1900.

Also that certain ranch containing about one hundred and sixty acres situated
about twenty-five miles east of Kennedy in said County of Humboldt heretofore known
as the Jersey Ranch. Said ranch is situated about one mile west of the Jersey
mine. Said Jersey Ranch is more fully described in the deed recorded on pages
195 and 196 in Book 27 of Deeds in the office of the County recorder of said County
of Humboldt to which deed reference is hereby made together with all water rights
and ditches thereunto belonging or heretofore used in connection with said ranches
or either of them.

TOGETHER with all and singular the tenements, hereditaments and appurtenances
thereunto belonging, or in anywise appertaining, and the reversion and reversions,
remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular the said premises, together with the ap-
purtenances, unto the said party of the second part, and to its ~~heirs-and-assigns~~
~~successors and assigns forever~~.
